Sir,

This has reference to your letters dated 23.04.2014 & 04.08.2014 on the above subject. It is noted that EC was accorded for the above project on 29.11.2004 and revalidated on 19.02.2014.


2. The matter was placed before the Expert Appraisal Committee (Thermal Power) in its 18th and 22nd Meetings held during August and September, 2014 respectively. In acceptance of the recommendation of the Expert Appraisal Committee (Thermal Power) and in view of the information/clarification furnished by you, with respect to the above mentioned power project, the Ministry accords amendment in the said EC for use of Air Cooled Condenser System in place of Water Cooled Condenser System. *The PP shall advertise in the newspaper and place on the website the above amendment for public information.*

3. Further, the following amendments are made in the environmental clearance issued vide letters of even no. dated 29.11.2004 and revalidation of environmental clearance dated 19.02.2014.

- (i) The water requirement in Para no. 2 and condition no. (xiii) of the EC shall be read as 2,180 m³/h instead of 10,100 m³/h.
- (ii) The condition no. (xi) is deleted as it has been addressed vide condition no. (xxxii).
- (iii) The condition no. (xxxv) is deleted as Air Cooled Condenser System in place of Water Cooled Condenser System and the water requirement is addressed in condition no. (xiii).

All other conditions shall remain the same.

4. This issues with the approval of the Competent Authority.
