1	The above-referred proposal was considered by the Expert Committee for River Valley & Hydroelectric projects at its meeting held on 18.10.2006 & reconsidered on 17.01.2007. The Lata Tapovan Hydro Electric Power Project 171 MW, (3x57MW) is a run of the river scheme across river Dhauliganga, a tributary to River Alaknanda & involves construction of a barrage near village Lata, Joshimath. The underground power house is located near village Tapovan, Joshimath (Chamoli). The approved capital cost of the project is Rs. 1527.00 Crores.	The Environmental Clearance of Lata Tapovan Hydro Electric Power Project was accorded by Ministry of Environment Forests & Climate Change (MOEF&CC) on 21.02.2007 vide letter No: J-12011/57/2006-IA.I.
2	The Environmental Management Plans - submitted by NTPC has been examined by the Ministry of Environment, Forests and Climate Change (MoEF&CC) hereby and accords environmental clearance as per the provisions of Environmental Impact Assessment Notification, 1994 & 2006, subject to strict compliance of the terms and conditions as follows:-	
3	<u>Part A: Specific Conditions:</u>	
(i)	Catchments Area Treatment Plan as has been proposed should be completed in three years.	<u>CAT Plan</u> CAT Plan approved by MoEF&CC was not acceptable to State Forest Department of Uttarakhand. On their demand, NTPC deposited Rs. 3 Lakhs for preparation of CAT Plan by them. State Forest Department submitted CAT Plan to NTPC and full amount of Rs. 16.377 Cr was deposited by NTPC. Till the date an expenditure of Rs 5.69 Cr has been incurred by Forest Department, Alaknanda Soil Conservation, Gopeshwar (the executing department) on execution of CAT plan.
