In continuation of our earlier disclosures dated 28th August 2025, 1st October 2025, 1st December 2025 and 1st February 2026 regarding transfer of coal mining business of NTPC Limited (NTPC) in phased manner to NTPC Mining Limited (NML), a wholly owned subsidiary of NTPC, we wish to inform that, in accordance with the amended Business Transfer Agreement (BTA) dated 17th September 2025, in the last and final tranche, Pakri Barwadih Coal Mine business located in Hazaribagh District (Jharkhand) along with Coal Mining Head Quarter (CMHQ) located at Ranchi (Jharkhand) has been transferred from NTPC to NML, w.e.f. 1st April 2026. Commercial operation (COD) of Pakri Barwadih North West Coal Mining Project is declared w.e.f. 1st April 2026.

With this, the hiving-off of the Coal Mining Business has been completed in all respects, and all coal mining units stand transferred to NTPC Mining Limited.
